



- 1. Continue work on DEI-related projects.

Revenue Sustainability



- 5. Seek collaborative grant opportunities among municipalities.
 - Received \$2.03M in grants with the assistance of the PARRC Planner, including private donor funding.
 - Received \$30K grant to begin the Regional Nature Based Placemaking Project.
- 6. Held first Annual Putt for Parks Event, resulting in a \$1,400 profit for the PARRC Foundation.

- 7. Ensure that each member has a parks and recreation board.
 - Washington Township re-established its Park Committee.

 - Monthly project and event updates provided by PARRC representatives.
