





Offering the Right Array of Services



1. Continue to expand recreational opportunities for all by improving ADA access on trails and in parks
2. Continue to expand recreational opportunities by providing new recreational facilities within parks.

3. Received \$2M in grants with the assistance of the PARRC Planner, including private donor funding.
4. Held second Annual Putt for Parks Event, resulting in a \$1,700 profit for the PARRC Foundation.
